In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.*, and the Rules and Regulations of the Federal Energy Regulatory Commission (“Commission”), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC (“Pelican”) hereby submits for filing FERC No. 2.22.0 to become effective July 1, 2024.

**I. Explanation of Tariff Filing**

**PUMPOVER CHARGE:** When crude petroleum is moved through the connection at Sacagawea Pipeline, New Town, Mountrail County, ND, a [I] 9.36 cent per barrel fee per 42 U.S. gallons will be charged. The above-stated pumpover charge shall also apply to any crude petroleum barrels received at the GBS 2, Mountrail County, ND receipt point for delivery to any of the indicated destination points.

Rates from any origin not specified above to any of the destinations listed above or any origin point to a destination point not specified above shall be charged a rate in accordance with the provisions of 18 C.F.R. § 341.10. Pursuant to 18 CFR 341.10(a)(2) Carrier will file a tariff publication applicable to these transportation movements if the intermediate point is to be used on a continuous basis for more than 30 days.
